This letter of authority covers monies and/or securities received or held by the Broker in one or more segregated account(s) on my/our behalf ("Client Assets"). Unless otherwise defined, all the terms used in this Authorization Letter shall have the same meanings as defined in the Securities and Futures Ordinance, the Securities and Futures (Client Money) Rules and the Securities and Futures (Client Securities) Rules as amended from time to time. Segregated account(s) include any account(s) designated as client account(s) established and maintained in Hong Kong in accordance with the Securities and Futures (Client Money) Rules and/or the Securities and Futures (Client Securities) Rules or account(s) designated as client account(s) established and maintained outside Hong Kong.

1. combine and consolidate any or all segregated accounts of my/our name maintained by Broker and/or any of Broker subsidiaries or affiliates from time to time, and transfer any sum of Client Assets to and between such segregated account(s) to satisfy my/our obligations or liabilities to any of Broker, whether such obligations or liabilities are actual or contingent, primary or collateral, secured or unsecured, or joint or several; and

4. This authority is given without prejudice to other authorities or rights which the Broker may have in relation to dealing in the Client Assets in the segregated accounts.

5. I/We acknowledge and agree that the authority shall be valid for 12 months and expire at the end of 12 months from the date of this Authorization Letter. I/We understand that the authority shall be deemed to be renewed for subsequent periods of 12 months on a continuing basis without my/our written consent if the Broker give me/us a written reminder at least 14 days prior to the expiry date and I/we do not object to such deemed renewal before the expiry date. I/We understand that I/we may revoke this authority by giving you at least five trading days' prior written notice. However, the Broker may, in your absolute discretion, treat the revocation notice as having immediate effect upon your receipt.
